



Peace and Plenty the reward of Temperance



HAT does one say to a body of people who wonder if it is all worth it? It is true that since 1998 when the Federal Government stepped in abolishing the State Friendly Societies Acts and creating one Federal Act that the roll of Friendly Societies in this country changed dramatically.

We were not the only, nor the first country to experience such changes. It seems Australia simply followed the British Government's policies in dismantling Friendly Societies that had served its people well for over a century.

No doubt at the time, there were good reasons for so doing. To my knowledge what those reasons were have not been made public. Some Society's may have been struggling financially and therefore a change of approach may have been needed, but that certainly was not the case of the Rechabites in Australia. As our members know, we had a strong financial base that ultimately was managed so well that all still living in the early 2000s enjoyed a share of the surplus funds that otherwise would have gone to the Government.

The member to thank for that was Sis Margaret Campbell, who should not be forgotten for the years of service she has given to the Rechabites both nationally and in NSW. As a little 7year-old she came to a Camp Parent begging that she be allowed to go to a Rechabite Camp her siblings were to attend. Permission granted, she was to grow up to play an active roll in the life of the NSW Order and becoming Chair of the former IOR National Board and with great wisdom guided our Society in the best path available at that time. To this day she continues to give her services to IOR.

Indeed, we have had to endue many changes in many areas of life, but one thing remains constant and that is the damage alcoholic beverages do to individuals and society as a whole. Our advocacy for the total abstinence from alcohol may not be popular, but its benefits cannot be denied.

As a Society, IOR may be crumbling. In England the Order became the Rechabite Insurance Company and was forced to drop its total abstinence philosophy. Here we face many hurdles and difficulties, but while ever we can make our voice heard, encourage others to share out vision, and support those who can fight in areas we many not be able to reach; we must press on.

I was encouraged by a NSW member who wrote a note to me saying, "I'm going to join your tent." Now whilst travelling from Sydney to Ipswich for *Hope of Ipswich Tent No.2* meetings might be out of the question, it shows that this member wants to belong and be part of our honourable Order for as long as possible. We have a job to do, lets do it to the best of our ability with the resources available, both financial and personnel.

Let us actively seek to encourage other like minded folk to join us in our stand for an alcohol-free society. It's not easy, but it's worth a try.

Sis Rae Belcher died on Friday 27th May after developing Alzheimer's Disease at the end of 2011. Rae was the first female District Chief Ruler in 1983-84. In her term of office, Rae was on the Ball Committee, the Social Committee and the Centenary Committee, which organised two weeks of celebrations in 1984.

From the NSW State Secretary

OOKING at the NSW Rechabite Honour Roll you can see that Sis Rae Belcher PDCR, served as District Chief Ruler in 1983-84. That was the Centenary year for NSW and she is the first Sister on the list. Expressions of condolence have been sent to the editor and family on behalf of the NSW Rechabites at the passing of Sis Belcher. Similar expressions were sent to Sis Jeanette Sheldon PSCR at the death of her mother, Sis Doris Evenden.

In the March, 2016 magazine I provided a summary of the 2015 Annual General Conference including the advice that a Winding-Up Committee was appointed with Bro Bob Breene PSCR, as Chairman. Since then each member was sent a form to vote on whether to wind-up or not. In addition there was a list of organisations to which it was proposed to receive the proceeds. The amounts favoured two of those organisations. The result was that the majority of members did not return their voting form. Those that did were heavily in favour of winding-up and distributing the funds in line with the proposal. The Special General Meeting held at Strathfield on Saturday, 9th April 2016 was attended by 22 members. Although deleted from the information to members and contrary to submissions, the State Deputy Ruler confirmed that he, with others, had been trying to wind-up the fraternity for years.

Thus while separate figures were not provided it would suggest that those attending the meeting would not have attained the 75% requirement once again. It is not clear what effect on voting was caused by calendars not being issued to members generally.

Even though not sighted at a Management Committee meeting it was reported that details for winding-up were forwarded to the Department of Fair Trading for consideration. At the time of writing the decision of the department is awaited. The department would think it unusual for an organisation with adequate funds to be wound-up. This is particularly so when the objects of the fraternity are being attenuated along with normal procedures and the legislation, certainly the principle of voluntary total abstinence.

IOR NSW Social 2016

holds an important place in the history of the Australian Independent Order of Rechabites. On Saturday 21st April 1883 the IOR Victoria District No 82 Nil Desperandum Tent No 4 was opened at Newtown and together with five other Tents that later established New South Wales District No 85. This Sydney suburb is where a group of nineteen met for the first NSW IOR Social this year on Saturday 2nd April.

Newtown is an area outside the designated precincts cited in the NSW Liquor Amendment Act 2014. Since the introduction of the lock out laws patronage and on-premises alcohol-related assaults have increased in the suburb. Newtown restaurant *Lentil as Anything* established a self-imposed alcohol-free zone in response. The not-for-profit organisation is within a two kilometre radius of approximately 28 bars and pubs.

As part of a community enterprise the restaurant opened Australia's first alcohol-free bar *Lentil on the Rocks*. Also a live venue it was designed as a social junction for non-alcohol drinkers on a Friday and Saturday night. Due to lack of financial support the project is now limited to catering for private functions and special events such as the 82nd birthday celebration of Bro Malcolm Campbell PSCR, *Excelsior Tent No 8*.

Of those years Bro Campbell spent some working at the NSW Registry of Births Deaths & Marriages behind Newtown Police Station. Having an office overlooking the street provided insight into the area as evidenced by the example of a couple who upon being married proceeded straight to the pub on the corner. The civic precinct also comprising of the former Town Hall, Courthouse and Fire Station was the start of the guided tour.

A Rechabite association was also made at the next location St Stephens

Anglican Church and Cemetery. The church was designed by NSW Colonial Architect Edmund Blacket, the grandfather of the late Bro Guyon Blacket of *Rose of Ashfield Tent No 6*. Constructed between 1871 and 1874 the building continues to be used for religious services, funerals and weddings with one such event providing an opportune viewing of the interior.

Beyond the church's stone walls is Camperdown Memorial Rest Park. The park under the Inner West Council is an Alcohol Prohibited Area between 9 pm and 9 am every day. According to local media reports at the time, minors were using the park during these hours to consume liquor. The City of Sydney Council has since removed a number of Alcohol Free Zones and Alcohol Prohibited Areas from streets and parks in Newtown.

Such issues would have been raised in the past at the final destination Newtown Bridge. At the beginning of last century the site was used by soapbox speakers. With the Newtown United Friendly Societies' Dispensary down the road one could imagine the members dressed in full regalia telling of sick and funeral benefits under a banner displaying the motto "PEACE AND PLENTY THE REWARD OF TEMPERANCE".

stored at the facility at Penrith, the State Deputy Ruler, Bro Bob Breene, PSCR salvaged a ballot box and marbles.

In the September 1998 issue of *The NSW Rechabite* Magazine (page 4) as part of the 120th Anniversary of *Captain Cook Tent No 1,* there was a picture of an IOR ballot box and marbles – that being one of several preserved at the Society's Offices.

New candidates for membership would be accepted or rejected by members of the Tent putting either a white or a black marble into a specially made box. This mode of voting was customary within society general-

ly at this period (1878). This box and marbles would seem to be the sole survivor of those then held.

Final Outcome

T the Annual Conference in October 2015, a special committee was appointed to investigate winding up the New South Wales Fraternity. Following on from recommendations made by that committee in January 2016, the New South Wales State Committee decided to call an Extraordinary General Meeting so that all members in New South Wales could decide whether they wanted the Society to wind up or not.

Every member of the Society was able to participate either by casting a vote in person at the meeting or by sending in a proxy vote. Over 25% of the New South Wales Fraternity took part in the ballot and of these an overwhelming majority voted for the Society to be wound up.

As a consequence, an application was made to the New South Wales Fair Trading Department to wind up our Society. Approval has been made for this to take place and the funds of the Society have been distributed in accordance with the decision of the Extraordinary General Meeting. An amount of \$5,000 was given to each of four small organisations involved in the support of temperance. Also \$5,000 has been put aside for IOR Queensland to assist them in absorbing those New South Wales members who wish to transfer to Queensland. The balance of the Society's funds was shared equally between the Australian Rechabite Foundation and FARF (Foundation for Alcohol Research and Education).

By the end of September, after the completion of the final few administrative tasks, the Department of Fair Trading will cancel the registration of the New South Wales Fraternity and we will cease to exist as an entity at that time.

A final thought – The collection of written records, photographs and other memorabilia of an organisation or a family serve to preserve our heritage. They are a record of who and what we are. Sadly, though, most times we lose these treasures not by fire, flood, or wilful destruction but by simple neglect.







Prior to becoming a member of Star of the Sea, Isa attended Young Excelsior Tent at Paddington with Sis Alice Morrison and Sis Jean Savage, enjoying all the activities provided. Isa fondly remembered the making of sandwiches under the supervision of Sis Alice Morrison who said, "now girls make sure you butter the sandwiches to the very edge please", in the kitchen of the Jacaranda Room at the Canberra Hotel in Ann Street where several Household Fairs were held. Isa was active in the Indoor Bowls Teams and her passion for cooking, needlework etc. rewarded her with many prizes at the Household Fair.

Unfortunately, in the later years Isa's health declined and although further care was provided at her home, after suffering a stroke in 2013, Isa was unable to return to Kedron and became a resident at 'Nazarene' Residential Aged Care at Rothwell. Isa's time at 'Nazarene' was made extremely pleasant by the caring staff and volunteers. Isa participated in activities where possible, attending concerts and Sunday Church Service. With the exceptional care provided, Isa remained at Nazarene until her passing aged 99 years and 9 months.

Sis Irenè Rae Belcher, PDCR

RAE, as she was known from birth, which took place in the NSW country town of Merriwa on 6th July 1932, knew nothing of the Rechabites until her marriage in 1959.

However, it was in 1979 that she was nominated by the late Bro. Gordon Hockings of *Perseverance Tent No.44*, Marrickville, to be considered for the position of District Guardian on the NSW District Executive. This was an historic occasion.

We quote here part of an article by Bro. W (Bill) S Williamson, Tent Rep. Concord Tent No.144 published in The NSW Rechabite Nov-Dec, 1979: "When the Secretary of our Tent,

Sister (Mrs) Rae Belcher was elected at the last Annual District Council Meeting to the position of District Guardian on the District Executive, she became the first female member of the Order in NSW to join that body.

"She became a Registered Wife in *Onward & Upward Tent No.17*, Burwood upon her marriage to Bro V A Belcher in 1959. It was through the influence of Bro Frank W Cabrera, the then Secretary of that Tent, that the Belchers, recently arrived from Queensland, began to take a greater interest in the Order.

"However, opportunity to serve did not present itself until many years later. In 1979 she became a Benefit Member in her own right and accepted the position of Secretary of Concord Tent No.144. (An office she held until 2000 when she returned to Queensland. Ed.)

"A Graduate of the Queensland Bible Institute (1958) Sis Belcher served with her husband in an international missionary society for 16 years as an able representative of that Society.

"She has been actively engaged in youth work for many years, (has four children of her own), and has been Branch Governor of the Church of England Boys' Society, Birrong Branch, for the past four years. She is the first Lady Leader in the Diocese of Sydney to hold that rank.

"Concord Tent congratulates our sister on her election to her new office and wishes her God Speed as she seeks to contribute to the good of the Order."

In 1983 Rae was to be come the first female District Chief Ruler in 100 years and to her lot fell the responsibility of conducting the Ten Day Centenary Celebrations of the Independent Order of Rechabites NSW District No. 85 Friendly Society. A roll she apparently handled well. A member spoke at the Annual Meeting three years later recalling the success of those Celebrations and concluded his remarks by saying, "... and nobody could have done it as well as Sis Belcher". How embarrassing! Yet nevertheless, an honour for a job well

done. Rae was to remain on the Executive until the 1993 AGM.

On returning to Queensland, she and her husband joined *Hope of Ipswich Tent No.2* where she ultimately became a Past Chief Ruler of the Tent.

Regretfully, her near brilliant mind succumbed to Alzheimer's Disease in 2012, which we believe was triggered by a car accident four years earlier. Mercifully, her deterioration was rapid and she died peacefully in her sleep at 8.36am on the morning of Friday 27th May, 2016.

It was truly an honour for her to serve as she did and an equal honour to have Executive Members of IOR Queensland District No.87 lead her coffin to the hearse as per The Ritual at the conclusion of her Funeral Service, at which 113 people were present, on Friday 3rd June. She has been a faithful Rechabite, as well as a wondeful loving and faithful wife, mother and friend to many.

We close with some of the opening words from her eldest son's Eulogy: "My mother was an extraordinary woman, whose lasting legacy will continue to ripple down the generations and even if the knowledge of her as the original source becomes lost, the benefits will continue none the less."

May it be so. She indeed, rests in peace.

Edward Robert (Ted) Francis, PCR

News in the present Rechabite magazine, but in times gone by the heading was *Tent Flaps*. My record of magazines

goes back to 1992 when it was *The NSW Rechabite* Magazine.

As for years prior, Bro Ted Francis included an article in *Tent Flaps* on behalf of *Excelsior Tent No 8* in the December 1992 issue. In the item he states the following "I also go back to the time when the Society was at it's zenith and in Leichhardt we had the *J.T. Jefferies Juvenile Tent*, the *F15 Female Tent* and the male *No.8 Excelsior Tent*... My wife, Sis Adah has the distinctive honour of holding the position of Chief Ruler in all three Tents and was the first female Chief Ruler for *Excelsior* in our Centenary year."

In the December, 1995 issue Ted advised that on 30th July they celebrated their 40th Wedding Anniversary. (On 3rd September Rechabites Sister-in-Law Rae and husband Bro Vic Manning also celebrated their 40th). Sadly Adah died on 28th October, 2002.

In the September, 1998 issue Ted reported that daughter Mary had given birth to a boy prematurely on 21st March. He was named David Francis Templeton. In the December 1998 issue Ted explained that this would make David a fourth generation Rechabite on both sides of their family and at the same time a fourth generation member of *Excelsior Tent*.

A Rechabite all his life, Ted was born on 23rd April 1926 and died 13th July 2016. Following an apprenticeship he qualified as a carpenter and joiner. Although of age before the end of World War II he was classified as being in an essential service as part of the war effort. Both daughters (Ann and Mary) were at the funeral together with grandson David who is now a fine young man. In fact Ted had previously provided David with an account of his life story that includes a number of other interests he had.

Both Ted and Adah represented Tent No.8 at Annual General Meetings. Ted broke all records as Chief Ruler of the Tent. He only relinquished the position on 10th June, 2008 after many years of service.

Retiring in 1976 John and his wife became 'grey nomads' for the next 8 years travelling around Australia. In October of the same year John was to become a committed Christian. By trade an electrician. They often became house-parents so that missionaries could have a break.

Polling on Late-Night Trading

New poling released last February by FARE has shown strong support for the late-night trading measures proposed by the Queensland Government

S several jurisdictions consider liquor licensing reforms to curb alcohol harms, industry lobby groups have been busy casting doubt on the evidence and opposing reforms. To separate fact from fiction and to hear from Australia's foremost experts on what works to reduce alcohol-related violence, the Queensland Coalition for Action on Alcohol (QCAA) are inviting NAAA members to a forum to discuss the Queensland legislation and the evidence supporting liquor licensing reforms. Further details about this event and the polling released are below.

2016 Queensland poll: Perspectives on Alcohol

Key findings from the 2016 Queensland poll: Perspectives on alcohol, undertaken by Galaxy Research, include:

- Almost three quarters (74%) of Queenslanders support late-night trading measures recently announced by the Queensland Government to reduce alcohol-related violence.
- The majority (80%) believe more needs to be done to reduce the harm caused by alcohol-related illness, injury, death and related issues, an increase from 2015.
- The majority (71%) expect alcohol related problems in Australia to remain the same or get worse over the next five to ten years.
- The majority of Queenslanders do not believe that governments (59%), alcohol companies (69%), and pubs and clubs (70%) are doing enough to address alcohol misuse. The proportions holding these beliefs have increased since 2015.
- Other policies that received major-

ity support include introducing a closing time for pubs, clubs and bars of no later than 3am (84%) and not selling alcohol in supermarkets (69%).

• Two thirds (65%) consider the city or centre of town to be unsafe on a Saturday night, an increase from 52% in 2015.

FARE are sharing this info on social media platforms both on Facebook and Twitter (@FAREAustralia) and using #QLDalcohol; we encourage you to do the same, even now. The story was picked up by a range of Queensland media outlets including the *Brisbane Times* and the *Courier Mail*.

What is FARE?

OW that is a good question. The Foundation for Alcohol Research and Education (FARE) is an independent, not-for-profit organisation working to stop the harm caused by alcohol.

Alcohol harm in Australia is most significant. More than 5,500 lives are lost every year and more than 157,000 people are hospitalised, making alcohol one of our nation's greatest preventative health challenges.

For over a decade, FARE has been working with communities, governments, health professionals and police across the country to stop alcohol harms by supporting world-leading research, raising public awareness and advocating for changes to alcohol policy. In that time FARE has helped more than 750 communities and organisations, and backed over 1,400 projects around Australia.

FARE is guided by the World Health Organization's (2010) Global Strategy to Reduce the Harmful Use of Alcohol for stopping alcohol harms through population-based strategies, problem directed policies, and direct interventions.

Bold Alcohol Tax Increase Delivers \$2.9 Billion Windfall

ATELINE - 8 March 2016: Modest but necessary changes to Australia's alcohol tax regime would deliver a \$2.9 billion dollar revenue boost to the Turnbull Government, and an even greater windfall for the health of the nation.

New economic modelling has found that a ten per cent increase to all alcohol excise, combined with changes that would tax wine more equitably, would result in a 9.4 per cent reduction in alcohol consumption, with a corresponding reduction in alcohol harms.

The Foundation for Alcohol Research and Education (FARE) says that with the additional tax revenue invested wisely in Australia's health system, the alcohol tax changes would further reduce the growing burden of chronic disease.

FARE's Pre-Budget Submission 2016-17 proposal would see wine and cider taxed according to the volume of alcohol, bringing wine into line with beer and spirits; before applying a ten per cent across-the-board increase on all alcohol excise.

The existing Wine Equalisation Tax (WET) would be replaced with a volumetric tax on wine and cider at a rate of \$56.56 per litre of pure alcohol (halfway between full-strength draught beer and spirits), and the WET rebate scheme would be abolished.

Replacing the way in which wine is taxed in Australia would ensure a fairer tax system where wine, which currently represents 40 per cent of all pure alcohol consumed but only 15 per cent of alcohol tax collected, pays for its share of the resulting alcohol harms.

Economic modelling by ACIL Allen Consulting and commissioned by FARE, forecasts such a change would generate \$2.9 billion in revenue while reducing the total alcohol consumed by 9.4 per cent.

FARE Chief Executive Michael Thorn says fixing Australia's broken alcohol taxation system and increasing the alcohol excise tax would have substantial benefits beyond the budget bottom line, and must be a priority.

"Reforming the alcohol tax system should be a no-brainer. In fact nine separate Government reviews have recommended we do exactly that. Increasing taxes on alcohol would not only address the budget deficit but, as research shows, is also the most cost-effective way to reduce alcohol consumption and the resulting harms, particularly among young people and risky drinkers," 1 Mr Thorn said.

Importantly, the proposed tax changes would have minimal impact on moderate drinkers. ACIL Allen Consulting examined the price increases under the proposed changes, with a schooner of full-strength draught beer increasing by only 5.5 cents, a can of premixed spirits increasing by 16.7 cents and a bottle of wine currently costing between \$15 and \$20 increasing by approximately \$3.80.

Alcohol use results in 5,500 deaths and 157,000 hospitalisations in Australia each year. FARE's Pre-Budget Submission 2016-17 argues that a proportion of the alcohol excise revenue collected must be directed to addressing the social costs of alcohol in Australia, which in turn would result in further savings to the health system.

FARE says that the additional revenue should target chronic disease prevention and research, with specific investment to help reduce the incidence of Fetal Alcohol Spectrum Disorders (FASD), to conduct strong public awareness alcohol harm prevention campaigns, and to introduce a structured screening and brief intervention program for alcohol.

"Reform of Australia's alcohol tax regime is long overdue and by wisely directing a proportion of that revenue we can start to address the high social cost of alcohol in this country; we can reduce the high levels of alcohol-related family violence, we can reduce the incidences of Fetal Alcohol Spectrum Disorders, and we can start to tackle this preventable health burden that is currently shouldered by the entire nation," Mr Thorn said.

Alcohol Causes 7 Kinds of Cancer

ACT Poll Supports 3.00am Last Drinks

Research and Education (FARE) commissioned ReachTEL to undertake polling of Australian Capital Territory (ACT) residents to gain an understanding on attitudes towards alcohol, perceptions of safety and support for trading hour 'last drinks' policies.

Outcomes

Key findings:

A majority (65.5%) of ACT residents support the ACT Government's

recent proposal to introduce 3am last drinks for pubs, clubs and bars across the ACT.

There is strong support for 3am last drinks across all age groups:

- 18 to 34 year olds (50.2%),
- 35 to 50 year olds (69.9%),
- 51 to 65 year olds (81.6%)
- and those over 65 (71.3%).

Nearly 40 per cent (39.9%) of ACT residents consider built-up areas in and around the city centre, Civic, to be unsafe or very unsafe on a Saturday night.

Respondents who report feeling unsafe or very unsafe in Civic are most likely to cite people affected by alcohol (36.2%) as the factor that contributes to this, almost double the proportion of residents who select people affected by drugs (20.1%).
